The grant will help the Newport Youth Theatre to run it's second youth theatre project 'Folktales of the Shire' from January to July 2023 and enable children from Lilleshall to benefit from attending the weekly drama workshops with children from the other Newport area schools, getting to know them and collaborating towards a final devised performance.
