19/197 Presentation by ONS Census Engagement Manager

Nicola Mewis, from the Office for National Statistics (ONS) gave a presentation to members to explain the process for the census that will be taken in 2021. The enthesis will be mainly online based initially and there will be a national campaign to encourage everyone to respond. Nicola asked the Parish Council if they could support the engagement with the census by communicating how to participate with the public and identify any communication barriers within our Parish and report these back to the ONS with suggestions of how we could support this locally.

c) Members considered a grant application received from the Lilleshall Tennis Club in the sum of 660.00 towards the general running costs of maintaining the building during what has been an unprecedented time for all. The club have had a loss of income due to the Covid-19 pandemic and other losses due to coaches finding employment elsewhere. After much discussion it was proposed by Cllr Taylor and seconded by Cllr Shaw that the Parish Council partially award the grant in the sum of 360.00, all were in favour thus **RESOLVED to approve the grant request to the sum of 360.00**. Cllr Eade kindly offered to award from his Pride Fund in the sum of 300.00 and would make the arrangements with the Tennis Club to do this.

Cllr Cornes noted that the appeal for Oak Barnes had been refused and that the buildings still remain in situ. The Clerk will investigate the timescale for removal of the buildings.

19/203 Chairman's Report

- It was noted that re-tarmacking of pot holes has been underway in and around the Parish recently.
- Conifers in graveyard have been reported to Idverde for cutting away from the path.

- Christmas lights at Church have been installed to the yew tree and turned on.
- A meeting has been held between representatives of the Parish Council, Cllr Eade and Western Power to find a more suitable solution to the new substation along Limekiln Lane.
 Western Power are to report back on options discussed which could see the plastic green container replaced with brick, which would be more sympathetic to local house design.

19/204 Clerks Reports

- Residents have been in contact recently to raise concerns with god fouling. Clerk has
 requested equipment from Telford & Wrekin to conduct "dog warden" surveys around the
 Parish to tackle the issue.
- An interim report has been received by PKF, the external auditors. Who raise concerns with
 the late submission of end of year accounts and publication of the notice of electors rights to
 examine accounts which the Clerk has actioned within the timescales requested by PKF.
- The "Parish Office" will remain open and manned by the Clerk every Tuesday and Thursdays between 09:30 to 14:30. However under the current circumstances of Covid-19 restrictions, the public must visit by appointment only.

Members to liaise with Clerk to identify areas of concern so he can coordinate a walk route. Clerk, Chair, Vice Chair and Cllrs Shaw and Cornes nominated to attend the Ward Walk with Cllr Eade.

Various areas of concern for the condition of the paths and highways were noted as reported to TWC on occasions and these will be revised as part of the Ward Walk.

Cllr Shaw has produced a report for the issue relating to the footpath and requested that this be submitted to Telford & Wrekin Council. Members were happy that this report be provided to all members and submitted to Telford & Wrekin Council in due course.
